Sub: Rate of Dearness Allowance applicable w.e.f. 01.07.2021 and 01.01.2022 to those Railway employees who continue to draw their pay in the pre-revised pay scale/grade pay as per 6th Central Pay Commission.

Please refer to this Ministry's letter of even number dated 07.09.2021 (PC-VI/406, RBE No.65/2021) revising the rates of Deamess Allowance w.e.f. 01.07.2021 in respect of railway employees continuing to draw their pay in the pre-revised pay scale/ grade pay as per 6th Central Pay Commission.

- 2. The rate of DA admissible to railway employees of above category shall be enhanced from the existing rate of 189% to 196% w.e.f. 01.07.2021 and from 196% to 203% w.e.f. 01.01.2022.
- 3. The provisions contained in Paras 3, 4 & 5 of this Ministry's letter of even number dated 09.09.2008 (S.No. PC-VI/3, RBE No.106/2008) shall continue to be applicable while regulating Dearness Allowance under these orders.
- This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

- 2. उक्त कोटि के रेल कर्मचारियों को स्वीकार्य महंगाई भत्ते की दर को 01.07.2021 से 189% की मौजूदा दर से बढ़ाकर 196% किया जाए और 01.01.2022 से 196% से बढ़ाकर 203% किया जाए।
- 3. इन आदेशों के तहत महंगाई भत्ते को विनियमित करते समय इस मंत्रालय के दिनांक 09.09.2008 के समसंख्यक पत्र (क्र.सं. पीसी-VI/3, आरबीई सं.106/2008) के पैरा 3, 4 एवं 5 में अंतर्विष्ट प्रावधानों को लागू रखा जाएगा।
