Sub: - Review of punishment norms in the cases of Signal Passing at Danger (SPAD)

Railway Board's vide letter of even no. dated 08.01.2018 had circulated revised punishment norms in the cases of SPAD.

Further Board's vide letter of even no. dated 26.10.2021 on the above subject followed by reminders dated 29.11.2021, 24.05.2022 and 27.06.2022, sought views of Zonal Railways on these revised norms of punishment in the cases of SPAD considering their experience of more than 3 years. Views of Zonal Railways have been received from NR, SCR, SECR, SER, SWR, SR & WR. It is requested that other Zonal Railways may also send their views at the earliest to facilitate a review of these punishment norms.

Meanwhile, till such time a review takes place, existing norms for imposition of punishment on Loco Pilots/Assistant Loco Pilots in cases of Signals Passing at Danger (SPAD) issued vide letter of even no. dated 08.01.2018 be followed.
