of service – setting of Gati Shakti Unit (GSU) in Divisions –

Procedure regarding.

संदर्भ /Ref: Railway Board's letter No.2021/W-i/Geni/Gati Shakti dated 27.07.2022

A copy of Railway Board's letter cited above is enclosed. With reference to para 3.0 of the above letter on Field Supervision and execution of works, the procedure order for reengagement of retired Railway Supervisors in exigencies of services is detailed below for necessary action.

- DRMs are empowered to re-engage retired Railway Supervisors in exigencies of service for setting of GSUs in their respective Divisions within the overall provisions in estimates of the projects being executed by the GSUs.
- Assessment for requirement of retired Railway Supervisors should be done by Gati Shakti Unit (GSUs) of concerned divisions and it should be vetted by Accounts with respect to availability of funds. After approval of DRM, requirement of retired Railway Supervisors should be notified accordingly, inviting applications for their reengagement. Notice period for the same will be one month.
- All Divisions will give wide publicity to such re-engagement by putting notification on Railway Website and Notice Boards.
- 4. All the Railway Retired Supervisors who have not attained 64 years 6 months on the closing date of notification (to ensure at least six months service is available after reengagement) for re-engagement purpose will be eligible.
- 8ased on the above, select list should be finalized. Suitability/competency of the staff should also be adjudged before engaging by JAG level officer. List of suitable retired supervisors may be put up for approval of the competent authority, through CPM/GSU concerned.
- Applications, as far as possible should be processed ONLINE for transparency.
 However, applications received OFFLINE should also be entertained.

- Monthly remuneration of a retired Railway supervisor should be determined as per Board's letter No.E(NG)II/2007/RC-4/CORE/1 dt 24.10.2019 (PBC No.258/2019).
- Eight days leave (on pro-rata basis) in a calendar year will be admissible as per RBE. No.118/2019 (PBC No.166/2019).
- The service of re-engaged RRS can be terminated after giving a notice period of one month.
- 10. This scheme is valid till further orders

Sub: Setting up of Gati Shakti Units in Divisions.

The Railway Board had approved setting up of Gati Shakti Units (GSUs) in Khurda Road, Bilaspur, Delhi, Bengaluru and Agra divisions to fast track the construction works required to remove bottlenecks in operations and improve mobility that would lead to increased cargo loading.

This decision was communicated vide Railway Board's letter No.17/W-I/Genl./Board Meetings dated 16.05.2022 and 09.06.2022. It was also decided that GSUs will be set up in all other divisions of Indian Railways in a phased manner.

In view of the above and Hon'ble PM's vision of Gati Shakti for creation of infrastructure in the country, it has been decided to start GSUs in all the remaining divisions of IR. The organizational structure of the GSUs will be as follows.

1.0 Organization of the divisional Gati Shakti Units:

- 1.1 GSU in the division shall be headed by a CPM/Gati Shakti (GS) under the administrative control of DRM. Post of CPM/GS will be open to all cadres (except IRPFS). CPM/GS will be selected based on his capabilities (knowledge & skills) and experience. GM will post suitable officers including CPM/GS in the GSUs of the divisions.
- 1.2 If divisions are having more than two ADRMs, the post of one ADRM will be re-designated as CPM/Gati Shakti of that division.
- 1.3 In case there are two or less ADRMs in the division, CPM/GS will be posted by making suitable adjustment in the cadre in accordance with the post codes mentioned in Annexure 'A' (at present) to fast track the execution of infrastructure works. However, in future, these post codes may be changed, if required by the GM.
- 1.4 Establishment expenditure of the Gati Shakti units including

that of CPM/GS shall be charged to the projects.

- 1.5 SG/JAG/SS/JS officers of Engineering, S&T, Electrical and Finance will be posted for major infrastructure development works such as station re-development, major yard remodeling, coal connectivity, port connectivity, traffic facilities works and ROB/RUB works. The post codes of these disciplines are mentioned in **Annexure 'A'**. GMs may however augment the GSUs by providing additional officers and staff, and provide further delegation of power based on regular reviews of progress of GSUs.
- 1.6 GM's in consultation with PCOM may decide about the traffic officer to be associated with CPM/GS. In case, a need is felt to augment the traffic establishment of the division, separate JAG/SG officers may be posted under the administrative control of CPM/GS.
- 1.7 Sr. DFM of the Division will be the associate Finance for the Gati Shakti Unit and establishment expenditure will continue to be charged to Revenue.
 - One Sr. Scale/Jr. Scale (DFM/ADFM) officer of Accounts Department along with Section Officer and other staff will be posted exclusively for Gati Shakti Unit in Division to exclusively work as the Associated Finance of GSU. They will work under the functional control of Sr DFM but administrative control of CPM /GSU for Gati Shakti Units.
- 1.8 Existing Branch officers of Engineering, S&T and Electrical discipline of the division will continue to do the works of Track Renewals (PH-31), Bridge (PH-32), Staff Welfare (PH-51), Station Building Maintenance, Signal & Telecom, as being done presently under the administrative control of DRMs.
- 1.9 The RET/PET surveys will henceforth be called Feasibility Study. The Gati Shakti Unit will also undertake Feasibility Study & preparation of DPR for projects keeping in view the vision of Railways. Necessary corrections in the Engineering Code are being processed separately. Division's Gati Shakti Unit may undertake feasibility study of projects required for the division at the rates communicated by Railway Board from time to time, with the finance concurrence of GS Unit, and with the approval of DRM. This expenditure will continue to be charged to Demand No 2. The proposals for undertaking feasibility study will be processed on IRPSM, and all such proposals would be monitored by PED/GS Railway Board.
- 1.10The feasibility study report will be examined by the Network Planning Group (NPG-Division) of the division.

Dy.COM/Planning/HQ may be co-opted in NPG of the division for deciding the feasibility of the project. DRM will approve the feasibility study based on the recommendations of the division's NPG.

1.11GMs are empowered to sanction works for the preparation of DPRs for such projects that are found feasible. Approval of the GM will be obtained by the division/Gati Shakti Unit for preparation of DPRs. DPRs will be prepared by Division's Gati Shakti Unit.

The DPRs duly approved by GM along with the Finance Concurrence of the division's Gati Shakti Unit shall be submitted to Gati Shakti Directorate of Railway Board. Finance concurrence of the Head Quarter will not be required.

2.0 Technical, Administrative and Financial Powers of GSUs of the Divisions:

- 2.1 CPM/Gati Shakti will have technical, administrative and financial powers analogous to the officers of construction organization for the projects executed by the division.
- 2.2 DRMs will exercise the powers of CAO/Construction for works of Gati Shakti Unit in the division.
- 2.3 Gati Shakti Units shall be facilitated to utilize the existing clerical, technical, drawing & design staff of the division for day to day works. DRMs will ensure this aspect.
- 2.4 Proposal requiring sanction of Railway Board will be sent directly to the GSU of Railway Board with concurrence of the associate finance of the GSU of the division, and with the administrative approval of the GM.
- 2.5 For design assistance from industry, design checking, testing of materials, site tests and surveys, the CPM/GS shall have powers of SAG officer of the construction unit.

Existing divisional units dealing with ESPs, SWRs, SIPs, and LOPs shall also assist the GSU. Further assistance, if required, may be arranged through outsourcing.

3.0 Field Supervision and Execution of works:

- 3.1 Gati Shakti Unit of division can use PSSA (Project Supervisors Services Agencies) and PMS as per the need of the project.
- 3.2 Gati Shakti unit of Division can hire retired railway supervisors below the age of 65 years with the approval of DRMs within the

overall provisions in the estimates of the projects being executed by the GSUs.

- 4.0 Gati Shakti Unit will monitor approvals of all Plans, L-Sections, ESPs, SIPs, LOPs, GADs, Yard plans, Blocks and PNIs/NIs of all the works executed by the GSU.
- 5.0 Officers/Sr. Supervisors in GSU may be permitted to travel by air in connection with Gati Shakti works, outside the Zonal Railways with the approval of DRM without finance concurrence.
- 6.0 Vehicles for field officers and supervisors shall be provided within the overall provisions in the estimate, to facilitate faster execution and supervision of works.
- 7.0 In case of shortage of accommodations in division/sub-division, leased accommodation nearest to the place of the works may be provided to officers and supervisors as per railway's extent rules with the approval of DRM.
 - House retention is also allowed at previous place of posting upto one year or scholastic year whichever is earlier.
- 8.0 GMs will nominate one SAG/ HAG Officer as zonal co-coordinator for the divisional Gati Shakti Units in respective zones.
- 9.0 The works to be executed by Gati Shakti Units of Divisions are given in **Annexure 'B'**.
- 10.0 This issues with the approval of Board (M/Infra, M/TRS, M/O&BD, MF and CRB&CEO).

WORKS TO BE UNDERTAKEN BY GATI SHAKTI UNIT

Divisional Gati Shakti Unit shall be responsible for planning and execution of following works

- Carry out feasibility study followed by preparation of Detailed Project Report for further consideration of Railway Board.
- 2. Station Re-development.
- 3. Plan Head 53: Passengers Amenities.
- 4. Plan Head 16: Traffic Facilities
- 5. Plan Head 29: Road Safety and level crossing.
- 6. Plan Head 30: Road Under Bridge (RUB) and Road Over Bridge (ROB).
- Plan Head33: Signal and Telecommunication such as EI, RRI including in private siding.
- 8. Plan Head 36: Provision of Escalator and lifts.
- 9. Plan Head 42: Work shop including production unit work.
- 10.All siding works and deposit work.
- 11. Electrification of sidings, workshops & small left over RE patches.
- 12.All coal connectivity projects/port connectivity works under different Plan Head (confined within the divisional boundary).

Note: GM may however decide the executing agency of the works based on urgency, need and peculiarity of the individual project for faster execution and delivery of the project without affecting the targets fixed for the current year.
