Sub: Implementation of Transfer Module of HRMS

Ref: Board's letter No. PC-VII/2022/HRMS/15 dated 28.09.2022 (copy encl.)

May please refer to Board's letter under reference wherein all Field Units were requested to verify the correctness of the legacy data and certify the same by 30th September, 2022 falling which, the process of assignment of priority will be initiated based on the data entered.

- However, only a few field units have complied with the aforesaid direction. Now it
 has been decided that the Transfer Module with all its features will be operational w.e.f.
 15th October, 2022 assuming that the data of all the units is complete and correct.
- 3. Accordingly CRIS has been advised to initiate the process of assignment of priority based on the legacy data entered. The responsibility of veracity of the data will remain with the office where the application has been registered. This will be informed in the transfer module page also.
- Considering the fact that sufficient time has been granted to the Field Units to complete the entry of legacy data and verifying the same, in case of any discrepancy, Zonal Railway concerned will be responsible for resolution of the same. For correction in exceptional circumstances of genuine cases, the Personnel officer in-charge of the field unit and in HQ the Dy CPO concerned will have authority to verify and send the request to CRIS for the correction.

Vide Board's letter under Ref (i), all the Field Units were advised to complete the entry of logacy data colating to Transfer by 12.08.2022 and subsequently vide Board's Letter under Ref (ii), the Transfer Module of HRMS was operationalised w.e.f. 15.08.2022 and further guidelines regarding entry of legacy data and variffication and certification of the same by the concurred Parascasel officers were issued vide Board's letter under Ref (iii). Till the time such logacy data is entered and certified, processing of all the Transfer requests were put on hold.

- 2 In this connection, it is observed that almost 45 days have passed since the commencement of process of outering of legacy data in HRMS. However, certification regarding entry and verification of legacy data has not yet been done by most of the Units. The enusing datay in processing the Transfer requests is resulting in distress to the end users and a large sampler of complaints and representations regarding comparationalization of Transfer Medule are being received in Board's office.
- 3. Kooping in view of the need to fully operationalize the Transfer Module, all the Units are requested to varify the entered legacy data and certify its correctness and conformity with the manual data available with the Units latest by Jith Sentember, 2022, fulling which it would be assumed that the data matered in the Transfer Module is correct and the entered data will be processed for assigning priority member.
