**Sub: Clarification on restriction of officiating pay under FR-35 in context of  
Railway Services (Revised Pay) Rules, 2016 –reg.**

Please refer to Board's letters No. PC-VII/2017/1/7/5/8 (RBE No. 127/2019) dated 08.08.2019 and dated 11.05.2020 regarding clarification on restriction of officiating pay under FR-35 in context of RS(RP) Rules, 2016. In this connection, few field units have referred the issue that while implementing the methodology of fixation of pay under FR-35, anomalous situation of officers drawing lesser pay on their regular JAG promotion, compared to the pay drawn by them during officiating appointment.

2. With respect to above, it is stated that above policy aspect has been referred to Department of Personnel & Training (DoP&T). Necessary clarification on the subject matter shall be issued as and when receives from DoP&T.
