Sub: Direct recruitment of Course Completed Act Apprentices (CCAAs) trained in Railway establishments with NAC from NCVT in Level-1 (7th CPC pay matrix) posts-Procedure reg.

Attention is invited to Board's letter No.E(NG)II/2019/RR-1/06 dated 13.04.2022 wherein it was advised to give due weightage to the extent of one third of the marks obtained in NCVT examination in preparation of final merit list after conduct of Computer Based Test (CBT) to CCAAs trained from Railway establishment and obtained National Apprentices Certificate (NAC) from National Council for Vocational Training (NCVT) in case of direct recruitment for posts in Level-1 of 7<sup>th</sup> CPC Pay Matrix.

In this connection, it is further clarified that in situations where the marks obtained after adding the NCVT score is less than that of the marks obtained originally in CBT, then the higher/ best of the two marks obtained by the candidate may be awarded for preparation of the final merit list.
