



Sub: Family Pension for Old Pension Scheme covered pensioner appointed in
Railway Service under NPS died while in service.
Ref: NCR's letter dated 23.09.2022.

Please refer to the letter under reference, vide which a clarification on the above cited subject has been sought.

2. With regard to the admissibility of second family pension to family member of the ex-servicemen who was governed by National Pension System(NPS) and died while in service, it is stated that instructions dated 29.05.2009 has been issued providing that in the case of death of employee governed by the National Pension System (NPS) while in service, the family will be given the benefit of old pension scheme duly following the rules/procedures of the Railway Services (Pension) Rules, 1993.

3. In terms of instructions issued vide letter No.F(E)III/2008/PN1/12 dated 04.01.2012 one family pension is not treated as income for grant of another family pension. Further, Rule 75(17) of the Railway Services (Pension) Rules, 1993, which was prohibiting for grant of second family pension, has since been omitted vide Notification No.2011/F(E)III/1(1)/9 dated 23.09.2013, and accordingly, the family of the ex-servicemen who was re-employed and governed under NPS, in the event of his death while in service, the family will be eligible for family pension admissible under Railway Services (Pension) Rules, 1993, also, in addition to the family pension admissible for military service.
