<u>Sub:</u> Clarification regarding cost ceiling of attendants engaged in lieu of TADK through contracted manpower outsourcing agency.

Ref: Board's letter of even no. dated 14.10.2022.

In partial modification to Board's letter under reference, para 2(ii) of Board's letter dated 14.10.2022 is amended as under:

"In cases where it is not possible to man the posts, an attendant in lieu of TADK may be provided by Zones through contracted manpower outsourcing agency subject to the cost ceiling (excluding other statutory obligation, Service Charge, GST and other administrative costs) of such attendant to not exceed bottom of Level-1 in the Pay Matrix of the 7<sup>th</sup> CPC plus applicable D.A."
