Sub:- Grant of 3rd financial upgradation under MACPS in GP 6600/PB-3 (Level-11) to Nursing Personnel.

Ref:- SR's letter No. SR-HQoHR(MEDL)/6/2022(236905), dt. 23-02-2023.

With reference to above, it is stated that issue of grant of 3rd financial upgradation under MACPS in GP 6600 to Nursing Staff who were granted 2nd promotion in Pay Scale 6500-10500/PB-3 with GP 5400 prior to and after 01.09.2008 has been re-considered in consultation with DoP&T. It is advised that nursing staff who had earned two financial upgradation under ACPS or two promotions before 01-09-2008 can be allowed benefit of financial upgradation under MACPS in terms of Para (a) of Board's letter dated 14-06-2018 (RBE No. 87/2018), those who have earned one financial upgradation under ACPS or one promotion before 01-09-2008 can be allowed benefit of financial upgradation under MACPS in terms of Para (b) and all the other remaining cases of Nursing Staff are covered under para (c) of the said letter.

2. Southern Railway is advised to re-consider the cases of grant of financial upgradation under MACPS to such staff in light of aforementioned instructions and action taken may be apprised to Board's office at the earliest.
