Sub : Provisioning of TADKs – policy instructions.

In partial modification of the above instructions, the following are issued.

- (i) It has been decided that in future, all provisioning of "attendants" in lieu of TADKs will be done through contracted manpower through outsourcing agency only.
- (ii) Only confirmed JAG and above level officers of Group 'A' service will be eligible for the provisioning of "attendants". The administrative approval for provisioning of an attendant in lieu of TADK for a particular eligible officer will be given by the respective DRMs/PHODs/CHODs.
- (iii) The existing posts of TADKs will remain distributed amongst various departments as they stand presently operated and will remain under the control of the respective DRMs/CWMs/ PHODs/ CHODs as indicated in **Annexure 'A'**.
- (iv) The provisioning of "attendants" in lieu of TADKs to cover aforesaid eligible officers will be met from the vacant non-safety Level-1 posts in the respective units to be identified by the respective unit heads viz DRMs/ PHODs/CHODs/CWMs.

- (v) The Unit heads viz DRMs/CWMs/CAOs will decide and nominate a nodal officer for executing the tender for outsourcing. For officers posted in Headquarters, DGM/G will be the nodal officer.
- (vi) The tender document currently being used in Headquarters may be used. However, unit heads may make modifications in the same wherever required.

This issues with the approval of the General Manager.
