Railway Board, vide letter dtd 09.01.23 under reference, conveyed its decision to include IRIDM's Disaster Management module in following manner:

iv	AMP at NAIR (for SG officers)	2 weeks @ NAIR + 1 week @ INSEAD*	<ul style="list-style-type: none"> • 1 day module at NAIR in existing 2 weeks NAIR component • If not attended earlier, 3 days at IRIDM after NAIR component

2. The above decisions were reviewed in the light of references received from NAIR and IRIDM and it has been decided with approval of competent authority that decisions of Railway Board communicated vide letter dtd 09.01.2023 should be implemented forthwith.

3. NAIR's existing programmes and IRIDM's Disaster Management Components will be integrated together and conducted as follows :

- a) The Disaster Management module will be integral component of these courses and attendance in both NAIR and IRIDM would be mandatory.

- b) Letter of NAIR calling for nominations will also mention about the mandatory Disaster Management component at IRIDM, Bangalore.
- c) The respective railway administrations will nominate their officers for both components at NAIR, Vadodara as well as at IRIDM, Bangalore (for period applicable as per para 1 above).
- d) NAIR and IRIDM will issue separate participation certificates for their respective components of training.
