In terms of Board's letter of even number dated 29.12.2020, retention of Railway accommodation at the previous place of posting in favour of officers/staff posted to Chittaranjan Locomotive Works (CLW) was permitted up to 28.12.2022.

2. Now, in exercise of the powers vested in it to make reasonable relaxations in public interest for a class/group of employees in all or any of the provisions regarding house allotment/retention, the Full Board have now decided that Railway officers/staff posted at CLW may be permitted to retain their Railway accommodation at previous place of posting upto 31.03.2024 subject to the conditions stipulated in Board's letter dated 01.07.2022
