- Sub: Complaints regarding Community Certificate cases.

In the light of the directions of the Railway Board contained in the letters No.2013-E(SCT)I/31/6 dt.18.10.2023, No.2013-E(SCT)I/31/6 dt.21.07.2020 & dt.15.07.2021 and the opinion of ASG vide letters No.ASGL/ARLS/DO/SRly/2024 dt.25.12.2023, dt.23.02.2024 & dt.09.03.2024, in partial modification of PBC No.100/2016, it has been decided that Para 'C' of the said letter may be read as under:

- 1) Procedure to be followed in cases where an employee is going to retire or already retired from Railway service, against whom <u>verification</u> of the genuineness of the community certificate is <u>pending at SLSC/DLVC</u> with regard to withholding/releasing of settlement dues (other than those cases specified in (2) below):
 - (i) Action advised in the Railway Board's letter dt.22.03.2022 (copy enclosed) should be taken. This letter inter-alia advises that, it is to be ensured that the verification of caste certificate of employees is completed expeditiously and, in any case, well before the date of their superannuation, in accordance with the instructions issued by the Department of Personnel & Training.

As advised in the above cited letter, unless Departmental or Judicial Proceedings are pending against the retiring employee, the Pensionary /Retirement benefits of the retiring employee should not be withheld or delayed on the ground of pendency of verification of caste certificate.

(ii) Where the enquiry/scrutiny of the caste certificate is still pending before the SLSC/DLVC and the retirement benefits have to be paid on account of Rule position as stated above, an Indemnity bond & Undertaking Affidavit as annexed herein may be obtained from the retiring employee to the effect that he/she would continue to co-operate with the scrutiny/enquiry before the concerned authorities for verification of caste certificate and in the event of the community certificate is found to be fake or the employee is found not to belong to the community as claimed, the entire retirement benefits would be repaid by him/her with interest.

- 2) Procedure to be followed in cases where an employee is going to retire or already retired from Railway service, in respect of whom dispute regarding <u>verification</u> of the genuineness of the community certificate is <u>pending before</u> <u>Judicial forum</u> or is <u>arising out of an order of a Court/Tribunal</u>.
 - (a) These cases can be of the following types:-
 - (i) Verification of community status by SLSC/DLVC is already completed and the community status of the employee has been <u>held to be fake or</u> <u>not genuine</u> by SLSC/DLVC and the findings of the SLSC/DLVC has been challenged by the employee before the Court of Law.
 - (ii) The decision of the SLCS/DLVC has been challenged by the Railway administration before Court of Law.
 - (iii) Cases referred/remanded to SLSC/DLVC as per the directions/orders of the Hon'ble High Court/ Hon'ble Central Administrative Tribunals/ any other Court of Law.
 - (b) Above such cases are to be treated as "Subjudice" and should be treated as cases where Judicial Proceedings are pending. In such cases, only after finalization of the Judicial Proceedings/Court cases, further action to disburse the retirement benefits should be taken as per Rule 9 (1) of Railway Services (Pension) Rules 1993.

Individual cases may be examined in the light of the above guidelines and suitable decision may be taken by the Pension sanctioning authorities on a case to case basis, duly keeping in mind the pending court cases and orders of the Court of Law.

INDEMNITY BOND

(This deed shall be made on Rs.100/- Non-judicial Stamp Paper)

This deed of Indemnity made on _____ th day of _____, 20____ by Shri/Smt. _____ aged ____S/o Shri/Smt. ______ who hereinafter shall be referred to as retiring/retired employee as may be read in the context required in favour of the President of India acting through ______, Southern Railway, ______ who shall be hereinafter referred as Employer.

The term retiring/retired employee and the Employer unless repugnant shall mean and include their respective legal heirs, legal representatives and Successors.

The employee retiring/retired from service of Southern Railway on _____ while working as _____ at ____.

Whereas the Employee has submitted Community certificate at the time of entering into service or during the course of service which the Employer has forwarded to State/District Level Scrutiny Committee for verification and the same is pending with them.

Whereas the Employer has agreed to arrange payment of retirement benefits viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc., to the retiring/retired employee on his retirement even during pendency of Community Certificate verification with State/District Level Scrutiny Committee. The retiring/retired employee is executing this deed of Indemnity with free will to receive payment of retirement benefits as the Community certificate submitted by him is under scrutiny before State/District Level Scrutiny Committee.

Hence, by this deed the retiring/retired employee shall indemnify and keep the employer indemnified against any loss or damages suffered by the employer owing to payment of retirement benefits viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc., that he/she would continue to co-operate with the scrutiny/enquiry before the concerned authorities for verification of caste certificate and in the event of the verification of community certificate issuing authorities observed that retiring/retired employee not co-operates with the respective authorities and if the community certificate is found to be bogus/fake/not genuine or the employee is found not belong to the community as claimed, does not belong to the community mentioned in the certificate produced by him and cancels/confiscate the certificate, the entire retirement benefits, viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc., would be repaid by me with prevailing rate of interest fixed by the government to the employer and it shall be recoverable from me or through my legal heirs, as an arrears of land revenue, as per the Revenue Recovery Act-1890.

The Employee/Retired Employee shall give undertaking separately to cooperate with the SLSC/DLVC to dispose the scrutiny of community certificate at the earliest point of time to secure the interest of the employer.

The Employee/Retired Employee shall intimate the progress of the case pending before the scrutiny committee periodically to enable the employer to proceed further.

The Employee/Retired Employee is well aware that if the SLVC/DLVC found that the Employee/Retired Employee does not belong to SC/ST and his/her community is fake/false or bogus/not genuine then appropriate action shall be initiated against me for the recovery of terminal benefits/received by me viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc., from the employer including criminal action in terms of Railway Board Letter No.9-E(SCT) 1/31/1 dt 31.05.1990

UNDERTAKING AFFIDAVIT OF

I, _____, S/o _____ aged about ____ years residing at do hereby solemnly affirm and sincerely state as follows

1. I am the deponent herein, I am swearing this Undertaking Affidavit for the purpose of getting terminal benefits, such as viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc.

2. I state that the verification of genuineness of my community certificate is pending before the SLSC/DLVC and I shall co-operate with them for the speedy finalization of verification of my community status.

3. I state that I shall intimate the employer the progress of the case periodically to enable the employer to take further course of action.

4. I state that I am well aware of the facts that if the SLSC/DLVC found my community certificate was fake or bogus or not genuine, I or my legal heirs shall repay the entire settlement benefit amount such as viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc., and I am also subjected to criminal proceedings. Hence I hereby giving undertaking with free will to comply with the legal requirement.

5. I state that I hereby giving undertaking to appear voluntarily before the employer as and when my presence is necessary to finalize the verification of community status by the concern authorities expeditiously.

6. I state that I hereby giving undertaking that I shall not adopt any illegal methods to defraud the employer for the due realization of settlement amount such as viz. Pension/Family Pension, Commutation, Gratuity, Leave encashment etc., if the community certificate was found fake/bogus/not genuine.

7. I state that I hereby undertake to abide by the terms and conditions of Service Rules on me by the employer concerned with verification of my community certificate by the concern authorities.

Subject: Non-payment/Delay in payment of retirement benefits on account of delay in verification of caste certificate in respect of retiring employees - Regarding

The undersigned is directed to say that instructions/ orders have been issued by Department of Personnel and Training (DoPT) from time to time for timely initiation/completion of verification of caste certificate of the employees. In spite of these instructions, completion of verification of caste certificate is inordinately delayed and, in many cases, the verification is not completed even till the retirement of the employee and pensionary/retirement benefits of such employees are not released till the completion of verification of caste certificate.

2. This issue has also been raised before the Parliamentary Committee on the Welfare of Scheduled Castes and Scheduled Tribes and the Committee has taken a serious note of the same. The Committee has directed to sensitize the concerned Ministries/ Departments/ organizations about the need for timely completion of verification of caste certificate and also for timely release of pensionary benefits to the employees in respect of whom verification of caste certificate is delayed due to administrative reasons or lapse.

3. The matter has been examined in this Department. In accordance with Rule 9 and Rule 69 of the Central Civil Services (Pension) Rules, 1972, a provisional pension may be sanctioned to an employee against whom any departmental or judicial proceedings are pending at the time of retirement. In that case, no gratuity shall be paid till the conclusion of the departmental or judicial proceedings and issue of final orders thereon. The Central Civil Services (Pension) Rules, 1972 or instructions/guidelines issued by this Department, however, do not provide for withholding of the retirement benefits under any other circumstances, including on account of pending verification of caste status of the employee.

4. All the Ministries/Departments are, therefore, advised to ensure that the verification of caste certificate of employees is completed expeditiously and, in

any case, well before the date of their superannuation, in accordance with the instructions issued by the Department of Personnel & Training. Unless departmental or judicial proceedings are pending against a retiring employee, the pensionary/ retirement benefits of the retiring employee should not be withheld or delayed on the ground of pendency of verification of caste certificate.

5. All the Ministries/Departments are also advised to bring these instructions to the notice of the attached/ subordinate offices under their administrative control for strict compliance.

6. All the Ministries/ Departments are directed to submit a quarterly report on number of employees whose pensionary benefits has been withheld due to reason other than pending administrative or judicial proceedings and the reasons thereof.
