Sub: Sanitization of employees' data in HRMS to avoid mismatch with IPAS.

With the launch of e-SR Module of HRMS, service related data of all the Indian Railway employees was entered into the HRMS system.

2. In this context, it has been observed that there are certain discrepancies in the data entered in HRMS with that existing in IPAS for around 14,000 employees leading to errors in operation of various HRMS modules for such employees.
