

Sub: Retention of Railway quarters at the previous place of posting by Railway officers/staff posted over SCoR Zonal Headquarters – reg.

On consideration of a request received from South Coast Railway, the Full Board, in the exercise of the powers vested in it to make reasonable relaxations in public interest for a class/group of employees in all or any of the provisions regarding house allotment/retention, have decided that the Railway officers/staff posted over SCoR Zonal Headquarters may be permitted to retain their Railway quarters at previous place of posting, on payment of normal rent, for a period of 03 years from posting (i.e, upto July, 2028) or till availability of residential facilities at SCoR Headquarters, whichever is earlier.




