**Sub:** Permission for retention of Railway accommodation at the previous place of posting for Level-16 and Level-17 Railway officers posted at Delhi – reg.


**Ref:** (i) Board's letter of even number dated 27.02.2023,

Attention is invited to letter under reference (i) above vide which AM level officers (Level-16) posted outside Delhi have been permitted to retain their Railway quarter at the previous place of posting. Further, vide letter under reference (ii) above, Board Members/CRB & CEO who during their immediate preceding posting were permitted to retain Railway quarter at their previous place of posting (just before becoming GM) have been allowed to retain such Railway accommodation.

2. Now, in order to ensure uniformity in the policy, full Board, in exercise of the powers vested in it to make reasonable relaxations in public interest for a class/group of employees in all or any of the provisions regarding house allotment/retention, have decided that Level-16 and Level-17 Railway officers posted at Delhi may be permitted to retain their Railway accommodation at previous place of posting on payment of special license fee in terms of para-3 of Board's letter No. E(G) 2021 RN 2-2 dated 01.07.2022.
